CRAFTS: All craft items shall be hand made. No manufactured, commercial, imported or kit work will be accepted.

NON PROFIT: All non-profit vendors shall be a fund raising program within Garfield County.

SET UP TIME: July 21, 2007 between 7 & 9 am. Set up will close promptly at 9 a.m.

SELLING TIME: 9 a.m. to dusk.

SPACE SIZE: 10'X10'(if your trailer or tent is larger 10'x10', you will have to purchase additional space. Both assignments are final and at the discretion of the Craft/Food committee.

ELECTRICITY: Please indicate if will you need electricity. Vendors are responsible for bringing their own heavy-duty extension cords.

TENTS & CHAIRS: Tents, tables and chairs are the responsibility of all vendors. Please plan for a hot, windy day with afternoon thunderstorms.

Vendor Liability Release
