## Rules & Regulations

1. Crews must be coed. (minimum one female or one male)
2. Maximum number of paddlers will be six (6), NO OARS.
3. All rafts and crewmembers must have the usual and standard safety equipment. To include but not limited to wearing a TYPE 3 or higher rated life jacket, no horse collar styles.
4. Bow line or stern line, a bailing devise for bucket boats.
5. Race type will be a lemans type start, head to head, with eddy stop and goes.
6. Team must physically touch the buoy or retrieve the token at each eddy before proceeding to the finish line.
7. Each team must finish with any tokens retrieved and all team members.
8. Race length is approximately one mile, Class 2 water.

## Liability Release

THE UNDERSIGNED, PARTICIPATING IN THE Burning Mountain Festival Raft Race:

Fully recognize and assume all risks and hazards involved in such an activity. Accept the responsibility of one designated driver for every crewmember. Willing to incur all responsibility for claims and personal injury and/or property damages to him or herself or fellow raft-racers or spectators, which might result from his or her negligence. Waiving all rights and claims against The Burning Mountain Festival, Town of New Castle, its Officers and Members of the Raft Race Committee, jointly or individually. Subject to revocation of the registration and forfeiture of the entry fee if, in the opinion of the Raft Race Committee, there is misconduct, misuse or nuisance on the undersigned's (one or all) part. Relinquishing all promotional rights before, during and after the Race event.

This form must be returned to the Committee prior to the start of the Race. The Committee will allow no crew to participate in the Race without this release.
